Inco Boundary

Large lower grade mineralization, ample opportunity to grow

- Last mineralized body drilled but not defined
- Low grade in nature but much larger if applying a lower grade cut ie @1% Ni 464,000t @1.2%Ni (5,590tNi)
 @0.5% Ni 2,790,000t @0.84%Ni (23,037tNi)
- Adjacent to Munda/Mt Edward 26N reduces
 potential development costs
- Increased Ni price/increased payability can lead to this becoming viable



EM survey identifies new targets

- Pipeline of projects at various stages of development evolving
- Preliminary EM survey defines
 new high order conductors
- Coincident with isolated massive sulphide occurrences
- Exploration to be undertaken in the year ahead

High-Grade Lithium Discovery- Faraday

Multiple high-grade lithium bearing pegmatites from rock chip sampling unlocks another avenue of growth

Key Facts

- Rock chip sampling at the Faraday prospect identified high-grade lithium bearing pegmatites over a 0.6-kilometre strike extent with surface expressions up to 25m wide.
- Multiple high-grade Li_2O values returned from 14 rock chip samples, with grades as high as 3.70% Li_2O .
- Immediately converted to drill target and subsequently drilled November. No impact on Nickel exploration

Armstrong- Major advances made towards mining

Scoping study and resource upgrade. Pivotal step towards self funding aspirations

- Two mining methods considered
 - Top Down Open stoping 500kt @1.9%
 - Bottom Up with fill 560kt @1.9%
- FCF @ spot \$22,000/0.63USD/AUD \$67-69M, max drawdown \$20.3M. At conservative \$US18,500/0.70 USD/AUD \$20-27M FCF, max drawdown \$24M.
- 27-33 month mining duration
- Low CAPEX, Simple underground conventional approach, high leverage to Ni price.
- Full steam ahead on preproduction activities
- Upgraded resource confidence leading to full feasibility in the new year





The on-ground activity continues...

- Infill drilling continues at Widgie Townsite, Gillett, Widgie 3, Munda. 132N to commence in the New Year. Faraday may increase drill requirements in New Year
- Resource Re-estimation Gillett and Munda to come
- Contractor laying pipe now for Armstrong dewatering
- Armstrong Metallurgical test work under way, offtake/ore tolling requirement
- All Faraday assays expected prior to Christmas. Optionality!
